



FOLLOWS:**

1. That the present understanding is for exposure of the students of 3rd year, 4th year and doing Internship Training programme of party no. 2 in clinical field and to understand the depth of operative surgery and operative gynecology or obstetrics as well as management in critical illness and use of USG machine, X-Ray Machine etc. at the super specialty Hospital run by party no. 1.
2. That the party no. 1 will be making available the required beds for teaching of the students along with exposure to Operation Theater, Labour room and Intensive care units where management of critical care of patients is being taken.
3. Party no. 2 will provide list of students in advance to the party no. 1 for exposure and understanding as a requirement.
4. The deputed students of Party no. 2 will be under strict supervision of the assigned teachers and will not disturb the routine of party no. 1 by their misconduct. They will follow the discipline, rules and regulations in the clinical areas as well as in Hospital premises of party no. 1.
5. On account of this attachment party no. 2 will pay Rs. 100 remuneration per student per year to party no. 1- the Hospital.
6. The period of this agreement/memorandum of understanding (MOU) will be initially for the period of five years with effect from 15/04/2018.





3. And to fulfill the above minimum requirements party no. 2 approached party no. 1 to have attachment for their students to have exposure in super specialty Hospital (of Modern Medicine).
4. And where as after discussion and negotiations the party no. 1 and Party no. 2 have arrived at understanding following terms and conditions.

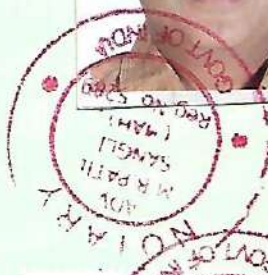
